## **Monthly Financial Report - May 2024**

Revenue for May is \$110,293, which is under budget by \$436

- Tax revenue for May is \$37,669, which is under budget by \$5,585
- Non-tax revenue for May is \$72,624, which is over budget by \$5,585
- Misc income was over budget by \$48,427 due to the receipt of insurance proceeds

Expenses for May totaled \$89,754 which is under budget by \$14,885

Personnel costs are under budget by \$19,806 due to no Wildland wages

**Year-to-date total revenue** is \$1,382,642, which is \$118,133 over budget **Year-to-date total expense** is \$1,382,147, which is \$203,637 over budget

Director Reh Bower expressed concern that the public did not have an appropriate opportunity to speak about the budget before it was due for approval. Mr Rodriguez from James Vincent Group stated that it is why the tentative budget is posted publicly for at least 20 days before the vote to approve the final budget.
